#### III. Health and Safety

1. How the LEA will maintain the health and safety of students, educators, and other school and LEA staff:

Description during SY20-21: We started the year in a hybrid model with cohorts so that we could provide students with high quality remote and in person instruction. In October we started bringing students back into the building 4 days a week. By December, all students that wanted in person instruction were in the building. We were able to provide in person instruction for the remainder of the 20-21 school year. We followed all mitigation strategies according to NH -DDHS and CDC recommendations.

Description during SY21-22: We will provide 100% in person instruction in the fall of 2021. We will keep some mitigation strategies in place and will base any mitigation strategy decisions on the COVID numbers in our community.

2. #### **Description of both SYs:**

20-21 Masks were worn when 6 feet of distance could not be maintained throughout the school day inside and outside for both children and adults.

21-22 Masks will be optional for fully vaccinated individuals. Masks will be optional for unvaccinated individuals based on current guidance from the NH DHHS as long as 3 feet of social distance is maintained inside the building and on school busses. When 3 feet can't be maintained masks will be recommended. Masks will not be required for children or adults when outside. Mask guidelines will adjust as needed based on local infection rates.

# b. Physical distancing (e.g., use of cohorts/podding and modifying facilities):

#### **Description of both SYs:**

20-21 Individuals maintained 6 feet of distance throughout the school day. Desks were 6 feet apart in all classrooms. Throughout the day 6 feet was maintained in all settings. Visual reminders were placed in halls and verbal reminders were provided at recess.

21-22 - Based on new guidelines from NH DHHS 3 feet of social distance will be required when inside the school building or the school bus.

#### **Description of both SYs:**

20-21 Hand washing/sanitizing stations were placed at every entrance. Students and adults were asked to sanitize when leaving and entering rooms within the building. Hand washing was done before eating and after outdoor play. Students and staff were educated on hand hygiene and respiratory etiquette and this was reviewed constantly throughout the year.

21-22 Hand washing/sanitizing stations will be placed at every entrance. Students and adults will be asked to sanitize when leaving and entering rooms within the building. Hand washing will be done before eating and after outdoor play. Students and staff will continue to be educated on hand hygiene and respiratory etiquette and it will be reviewed throughout the year.

#### **Description of both SYs:**

20-21 Windows were encouraged to be opened throughout the year, cleaning throughout the day was increased, cleaning logs were maintained, air filters were changed quarterly, building air exchange was completed at the end of every day and extra cleaning staff was hired.

21-22 Windows will be opened throughout the year, increased cleaning throughout the day will continue, cleaning logs will be maintained, air filters will be changed quarterly, the building air exchange will be completed at the end of every day and extra cleaning staff will be on staff.

#### **Description of both SYs:**

20-21 - Seating charts and checklists were maintained for recess to assist in contact tracing. Assigned seats on the bus were required and classroom seating charts were maintained. Individual in depth interviews with any family/staff that reported illness was completed as well as working with NH-DHHS when necessary.

21-22 Assigned seats will be maintained and seating charts will be provided to the school nurse in the case we need to contact trace. We will continue to work closely with parents and staff when any illness is present. We will follow NH-DHHS guidelines around isolation and quarantine. We will reach out to NH -DHHS as needed.

#### **Description of both SYs:**

20-21 All staff were invited to join a POD clinic that was provided by the Nashua Department of Health. Staff were given time off to receive vaccines or recover from side effects without penalty. We shared information with families on where to obtain vaccines and vaccine safety.

21-22 We will continue to educate families and staff about the importance of vaccinations and provide staff with information and or access to any future booster that becomes available.

20-21 We worked with all families that were concerned with in person learning and provided remote instruction until they were comfortable sending their child back to school. All special education services were provided throughout the pandemic either remotely or in person.

20-21 Weekly/Monthly webinars with NH DOE and NH DHHS to stay up to date with the most recent information.

21-22 We will continue to participate in any offered webinars/training with the DOE or NH DHHS.

Description during SY20-21: Our students received a full year of academic instruction. They received 5 days of instruction from a certified educator either in person or remotely. All students were fully in person by December of 2020.

Description during SY21-22: All students will receive in person instruction for the 21-22 school year.

2. The LEA has provided continuity of services in addressing student social, emotional, mental, and other health needs, which may include student health and food services:

Description during SY20-21: As school we used a schoolwide social emotional program (Choose Love). Any children needing additional support were provided that by the school psychologist. The school psychologist supported classroom teachers in implementing many coping and stress reducing strategies. All students had access to free breakfast and lunch throughout the 20-21 school year.

Description during SY21-22: We will continue to use a school wide social emotional program and all children will have access to the school psychologist. Free breakfast and lunch will be provided for the 21-22 school year.

3. The LEA has provided continuity of services in addressing staff social, emotional, mental, and other health needs:

Description during SY20-21: We supported the staff both personally and professionally. They were given time off when needed for any COVID related illness or incident without penalty. They had access to the school psychologist. We provided staff with morale boosting events throughout the year. Professional development was provided to strengthen their ability to teach remotely.

Description during SY21-22: We will continue to support the staff both personally and professionally. They will be given time off when needed for any COVID related illness or incident. They will continue to have access to the school psychologist. We provided staff with morale boosting events throughout the year. Professional development was provided to strengthen their ability to teach remotely.

#### V. Plan Review

## Appendix A. ARPA Statutory Excerpt

"(i) Safe return to in-person instruction.-

- (1) IN GENERAL.—A local educational agency receiving funds under this section shall develop and make publicly available on the local educational agency's website, not later than 30 days after receiving the allocation of funds described in paragraph (d)(1), a plan for the safe return to in-person instruction and continuity of services.
- (2) COMMENT PERIOD.—Before making the plan described in paragraph (1) publicly available, the local educational agency shall seek public comment on the plan and take such comments into account in the development of the plan.
- (3) PREVIOUS PLANS.—If a local educational agency has developed a plan for the safe return to in-person instruction before the date of enactment of this Act that meets the requirements described in paragraphs (1) and (2), such plan shall be deemed to satisfy the requirements under this subsection."

# Appendix B. Interim Final Requirements of ARP ESSER Excerpt

- "(3) LEA Plan for Safe Return to In-Person Instruction and Continuity of Services.
  - (a) An LEA must describe in its plan under section 2001(i)(1) of the ARP Act for the safe return to in-person instruction and continuity of services—
    - (i) how it will maintain the health and safety of students, educators, and other staff and the extent to which it has adopted policies, and a description of any such policies, on each of the following safety recommendations established by the CDC:
      - (A) Universal and correct wearing of masks.
      - (B) Modifying facilities to allow for physical distancing (e.g., use of cohorts/podding).
      - (C) Handwashing and respiratory etiquette.
      - (D) Cleaning and maintaining healthy facilities, including improving ventilation.
      - (E) Contact tracing in combination with isolation and quarantine, in collaboration with the State, local, territorial, or Tribal health departments.
      - (F) Diagnostic and screening testing.
      - (G) Efforts to provide vaccinations to school communities.
      - (H) Appropriate accommodations for children with disabilities with respect to health and safety policies.
      - (I) Coordination with State and local health officials.
    - (ii) how it will ensure continuity of services, including but not limited to services to address students' academic needs and students' and staff social, emotional, mental health, and other needs, which may include student health and food services.
  - (b) (i) During the period of the ARP ESSER award established in section 2001(a) of the ARP Act, an LEA must regularly, but no less frequently than every six months (taking into consideration the timing of significant changes to CDC guidance on reopening schools), review and, as appropriate, revise its plan for the safe return to in person instruction and continuity of services.
    - (ii) In determining whether revisions are necessary, and in making any revisions, the LEA must seek public input and take such input into account.
    - (iii) If at the time the LEA revises its plan the CDC has updated its guidance on reopening schools, the revised plan must address the extent to which the LEA has adopted policies, and describe any such policies, for each of the updated safety recommendations.
  - (c) If an LEA developed a plan prior to enactment of the ARP Act that meets the statutory requirements of section 2001(i)(1) and (2) of the ARP Act but does not address all the requirements in paragraph (a), the LEA must, pursuant to paragraph (b), revise and post its plan no later than six months after receiving its ARP ESSER funds to meet the requirements in paragraph (a).
  - (d) An LEA's plan under section 2001(i)(1) of the ARP Act for the safe return to in-person instruction and continuity of services must be—
    - (i) In an understandable and uniform format;
    - (ii) To the extent practicable, written in a language that parents can understand or, if it is not practicable to provide written translations to a parent with limited English proficiency, be orally translated for such parent; and
    - (iii) Upon request by a parent who is an individual with a disability as defined by the ADA, provided in an alternative format accessible to that parent."
