	Shall the Mason School District raise and appropriate as an operating budget, not including appropriations by special warrant articles and other appropriations voted separately, the amounts set forth on the budget posted with the warrant or as amended by vote of the first session, for the purposes set forth therein, totaling Three Million, Nine Hundred Thirty Six Thousand, Thirty Two Dollars (\$3,936,032). Should this article be defeated, the default budget shall be Three Million, Eight Hundred Twenty Six Thousand, Two Hundred, Seventy Two Dollars (\$3,826,272) which is the same as last year, with certain adjustments required by previous action of the Mason School District or by law; or the governing body may hold one special meeting, in accordance with RSA 40:13, X and XVI, to take up the issue of a revised operating budget only. The School Board recommends this warrant article. (Majority vote required.)
